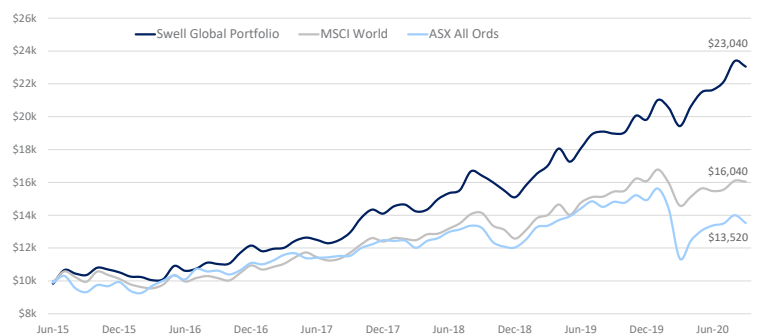

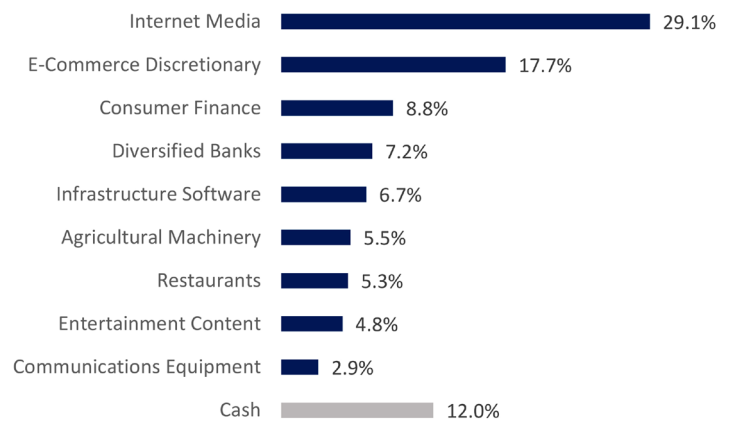
Portfolio Performance vs Benchmark



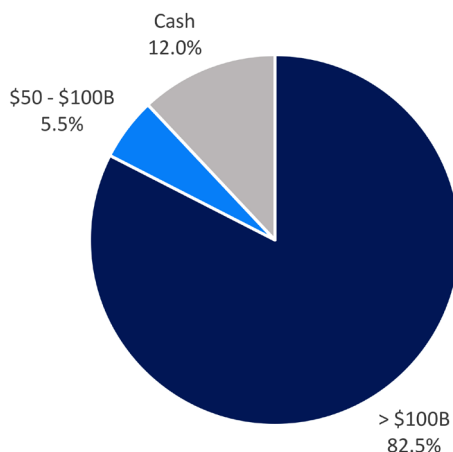

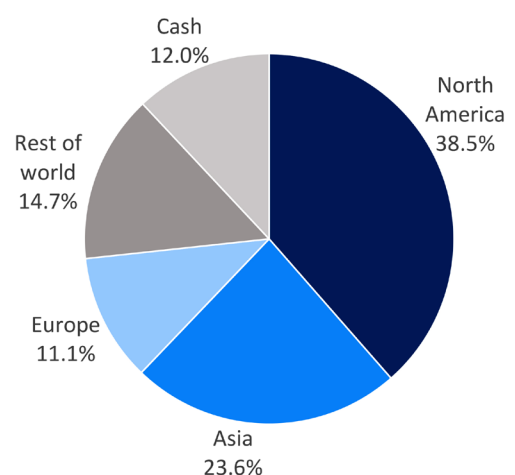
Sector allocation by BICS Industry
